



GIVING FOR THE FUTURE

INDIVIDUAL RETIREMENT ACCOUNTS

A gift from the donor's individual retirement account during the donor's lifetime may avoid income tax on the amount of the gift and may also satisfy a donor's annual required minimum distribution. This type of gift is classified as a Qualified Charitable Distribution ("QCD"). Please discuss a gift of IRA assets with your tax advisor.

Because the Frederik Meijer Gardens & Sculpture Foundation ("Foundation") is a Type III supporting organization under the tax law, QCD's and required minimum distributions are subject to special rules and thus, **a donor should normally make the QCD or required minimum distribution gift directly to the Frederik Meijer Gardens & Sculpture Park ("Meijer Gardens"). Donors may designate individual retirement account gifts to the endowment of Meijer Gardens.**

Gifts designated to the endowment will be included in the Donor's cumulative giving to the Foundation. The Foundation is a single-purpose foundation with an endowment fund to support Meijer Gardens. Financial support from the Foundation's endowment plays an important role in maintaining the world-class botanical gardens, sculpture collection, art and educational programs which have become the hallmark of Meijer Gardens.

A gift or pledge of \$1,000 or more qualifies for permanent recognition by the Foundation.

Donors are entitled to establish a named fund, restricted or unrestricted, by making a gift or pledge of \$10,000 or more.

The Foundation has two distinctive Societies that members may join, the Perennial Society and the Bonsai Society. Membership into these societies is available to individuals whose cumulative cash gifts, pledges and/or estate plan gifts are \$10,000 or \$100,000 respectively.

Membership into a Society is for individuals who have made a provision in their will or estate plan. To receive permanent recognition, donors must submit a copy of the gift provision in their will or estate plan, or have other written documentation, verifying that the minimum has been met. If the plan calls for a percentage of the estate's remainder, and the amount will be over the minimum amount required for membership, a written statement from the estate planner, tax consultant or attorney would meet the requirement for membership.
